#548 - Order that residents of the following addresses (7 Crombie St., 11 Church St., 281 Essex St., 51 Lafayette St., 50 St. Peter St., Townhouse Square Condos, 141 Washington St.) required to purchase parking passes at either the Museum Place or South Harbor Garage shall be granted 1 month parking pass, allowing them to park upon any street granted temporary resident only parking status between 10/1/18 -10/31/18, either by ordinance or order.
