In accordance with Chapter 30A, Section 20 of the General Laws, as amended, NOTICE of an EMERGENCY SPECIAL MEETING of the SALEM HOUSING AUTHORITY to be held on THURSDAY, MAY 30, 2024 at 1:00 p.m. via Zoom Webinar.

It is anticipated by the Chair that the matters outlined in the attached agenda will be discussed, as well as any other unforeseen business that may lawfully come before it.

It is also anticipated by the Chair that the Board will convene into Executive Session for the following reason:

(1) To discuss the reputation, character, physical condition or mental health, rather than professional competence, of an individual, or to discuss the discipline or dismissal of, or complaints or charges brought against, a public officer, employee, staff member or individual. The individual to be discussed in such executive session shall be notified in writing by the public body at least 48 hours prior to the proposed executive session; provided, however, that notification may be waived upon written agreement of the parties. A public body shall hold an open session if the individual involved requests that the session be open. If an executive session is held, such individual shall have the following rights:

- i. to be present at such executive session during deliberations which involve that individual;
- ii. to have counsel or a representative of his own choosing present and attending for the purpose of advising the individual and not for the purpose of active participation in the executive session;
- iii. to speak on his own behalf; and
- iv. to cause an independent record to be created of said executive session by audio-recording or transcription, at the individual's expense.

The rights of an individual set forth in this paragraph are in addition to the rights that he may have from any other source, including, but not limited to, rights under any laws or collective bargaining agreements and the exercise or non-exercise of the individual rights under this section shall not be construed as a waiver of any rights of the individual.



Estimada Sra. Simons:

De conformidad con el Capítulo 30A, Sección 20 de las Leyes Generales, según enmendadas, AVISO de una REUNIÓN ESPECIAL DE EMERGENCIA de la AUTORIDAD DE VIVIENDA DE SALEM que se llevará a cabo el JUEVES 30 DE MAYO de 2024 a la 1:00 p.m. a través del seminario web Zoom.

Se prevé por parte del Presidente que se tratarán los asuntos señalados en el orden del día adjunto, así como cualquier otro asunto imprevisto que legalmente pueda presentarse ante él.

El Presidente también prevé que la Junta se reunirá en Sesión Ejecutiva por el siguiente motivo:

(1) Para discutir la reputación, el carácter, la condición física o la salud mental, en lugar de la competencia profesional, de un individuo, o para discutir la disciplina o el despido, o las quejas o cargos presentados contra, un funcionario público, empleado, miembro del personal o individual. El individuo que será discutido en dicha sesión ejecutiva deberá ser notificado por escrito por el organismo público al menos 48 horas antes de la sesión ejecutiva propuesta; siempre que, sin embargo, se pueda renunciar a la notificación mediante acuerdo escrito de las partes. Un organismo público celebrará una sesión abierta si el individuo involucrado solicita que la sesión sea abierta. Si se celebra una sesión ejecutiva, dicha persona tendrá los siguientes derechos:

- i. estar presente en dicha sesión ejecutiva durante las deliberaciones que involucren a ese individuo;
- ii. tener un abogado o un representante de su propia elección presente y asistiendo con el propósito de asesorar al individuo y no con el propósito de participar activamente en la sesión ejecutiva;
- iii. hablar en su propio nombre; y

iv. hacer que se cree un registro independiente de dicha sesión ejecutiva mediante grabación de audio o transcripción, a cargo del individuo.

Los derechos de un individuo establecidos en este párrafo son adicionales a los derechos que pueda tener de cualquier otra fuente, incluidos, entre otros, los derechos bajo cualquier ley o convenio colectivo y el ejercicio o no ejercicio del individuo. Los derechos bajo esta sección no se interpretarán como una renuncia a ningún derecho del individuo.


