- 2. Delete SECTION 000110 TABLE OF CONTENTS dated June 14, 2017, Insert SECTION 000110 TABLE OF CONTENTS dated July 26, 2017.
- 3. In SECTION 015000 TEMPORARY FACILITIES AND CONCTROLS, 2.04 SECURITY AND PROTECTION FACILITIES, D, Temporary Site Enclosure Fence, add, '2. Enclosure Fencing to be constructed to allow for continued use of bus shelter and crosswalks nearest bus stop throughout the project. The remaining sidewalks on the perimeter of the park do not need to remain open for use. Exact location of the enclosure fencing to be proposed by Contractor and reviewed by City Traffic Engineer prior to installation.'



Potential locations for cabinet include but are not limited to a new free-standing cabinet, an underground vault, or mounted within or to the outside of existing utility boxes, as possible.'

- 7. On drawing L4.0 PLANTING PLAN, PLANTING REFERENCE NOTES, replace #1 with-'Provide sprinkler heads for all lawn and new trees on interior of park. Lawn and trees located on the berm between the sidewalk and street to have no permanent irrigation.'
