## **Public Comment**

- Pat Gozemba (Salem Alliance for the Environment "SAFE" Co-Chair)
  - Pat sent an email to John Hayes on the issue of banning gas leaks. There is a large number of SAFE members who are interested in this topic and they are currently discussing a draft on a gas leak ban ordinance with Councilor Dibble.
  - Pat discusses a program called Rocky Mountain Institute which provides the City an opportunity to participate in a workshop regarding eliminating fossil fuels in new buildings and moving towards full building electrification.
  - Pat is asking for a show of hands with interest from SERC in case there is an opportunity for Salem to be involved in the program.
    - John Hayes Communities in MA are waiting for a resolution on this. We can be ready to hit the ground running.
    - Jeff Cohen We will send the email to the committee and if anyone wants to participate, they're more than welcome to.
    - John Hayes our committee should really think about the pros/cons with any initiatives and projects that we recommend. We are an advisory



committee to the Mayor, so we should discuss all viewpoints. Let's discuss more at the next SERC meeting.

# En-Roads Presentation by Kendra Bowker and Katie Farrell of CCL NS (Citizens Climate Lobby, North Shore Chapter)

- Jeff Cohen The value of En-ROADS is that some categories have a dramatic effect while others have smaller effects. It's very interesting to view. If we electrify everything, we can fuel it through renewable energy.
- Doug Bowker We need a system to measure carbon footprint of certain behaviors.
- John Hayes It would be great to have a system like this for the U.S. government and looks at all of our policies and how much it is helping.
  - Katie Farrell C-ROADS is a predecessor to En-ROADS; there are talks about having a system like this for different countries around the world.
- Jenna Ide We should all be looking for different tools like En-ROADS to figure out emissions/climate change data. Engagement and outreach tools as well. We need to think outside the box for ways to engage people.
  - Pat Gozemba Project Drawdown is a different template looking at different solutions to climate change and environmental/social issues.

  sample of an ordinance that incorporates SERC to be part of legal processes in the City
  when it comes to sustainability, resiliency, and energy policies.
  - The ordinance is going to be comprehensive strengthens minimum standards on solar, etc., if no solar then a green roof.

# • Beverly & Salem Climate Action Plan

- The Cities of Beverly and Salem jointly went out to seek proposals from consultants for a Climate Change Action Plan. This plan will look at City wide (not just owned) emissions and come up with a plan for reduction/mitigation. We will also discuss other sustainability issues such as waste, water, and food.
- Jenna Ide Beverly got a grant for the Climate Change Action Plan and Salem is applying for one. We got six proposals from the RFP. We have a committee that will be reviewing these through a combination of qualification and price. The process of choosing ends in May and we will begin working on the plan starting in June/July (next fiscal year).
- The plan will help us review our current state/emissions then we can decide our goals moving forward.

### **New Business**

- The City of Salem is applying for the MA Department of Energy Resources (DOER) Green Communities grant; the application is due on May 1, 2020. We are applying for the following items:
  - o Two Salem Police vehicle replacements to Hybrid Police vehicles.

- Kitchen appliance replacements to Energy Star Rated appliances at the Salem Police Station, Horace Mann Laboratory School, and Witchcraft Heights Elementary School.
- Two electric vehicle charging stations one at Forest river park and one at Blaney Street Parking Lot (this is part of a larger project to bring over ten EV charging stations to the City).
- Building Operator Certification (BOC) training for City buildings and School department facility managers.
